DUE DATES

Payment of tuition is due before the first class day of each semester if paying in full. Payment plans are available for the current semester only via SMURF.

CREDITS ON STUDENT ACCOUNTS

When a credit balance is present on a student's account, disbursements will be processed within 14 days after the first day of class. If the credit balance occurs after the term has started, the credit balance will be disbursed within 14 days of the credit balance. This does not apply to tuition deposits.

NONPAYMENT OF TUITION AND FEES

Accounts in "good standing" are defined as: (1) paid-in-full (i.e. zero balance), (2) enrolled in a payment plan and making payments on or before the due dates, or (3) a documented/approved third party payment agreement that covers all outstanding balance.

Students who have a delinquent balance on their student account will receive a "business office hold" preventing registration in a future semester. If a student is enrolled in a payment plan and misses two consecutive monthly payments, SMU reserves the right to cancel the payment plan and place the student on a "Business Office Hold."

CLASS DROP AND WITHDRAWALS

Students who drop a course(s) during the add/drop period, but remain enrolled in other courses during the same term, will receive a 100% refund on the dropped course(s). A student will not receive a refund if a class is dropped after the add/drop period.

Students who withdraw from the university, take a leave of absence, or are dismissed from Samuel Merritt University programs for any reason, will owe for current semester units based on the date of withdrawal (see <https://www.samuelmerritt.edu/admission/student-accounts>)
